## New Invasive Introduced to PA

The PA Department of Agriculture has confirmed the first report in the US of the Spotted Lantern Fly in District and Pike Township in Berks County, PA. The tree hopper originated from Asia is known to attack grape, apple, pine and 70 other plant species that grow in PA. Steps are taken to address this issue. Quarantine on plant, wood, and stone products is in effect for the townships and may spread others if there are confirmed sightings. The Department is working with the state and federal government to develop a comprehensive plan to prevent it from moving to other areas in the Commonwealth. The department is urging anyone who has seen the eggs masses, nymphs, and adult to notify them immediately. Steps for reporting any sighting are described on the Department of Agriculture's web site. ## New WoodMobile Debuts at PA Farm Show!

The Pennsylvania Department of Agriculture in cooperation with the Hardwoods Development Council once again had a beautiful and popular exhibit showcasing Pennsylvania's vital hardwood industry at the 99th Pennsylvania Farm Show, January 10-17, 2015. The display was included as the "Hardwood Commodity" located in the Main Exhibition Hall in direct line of visitor traffic for the Butter Sculpture and the popular butterfly exhibit. The theme for the display was "Pennsylvania Hardwood: Treasured for Generations" building on the promotion tag line for the new check-off program being considered by USDA and industry. The exhibit had something for everyone and was officially designated as one of the top five exhibits at the Farm Show.



The HDC display drew people into an open area that featured seven hardwood floors showcasing various secondary wood products that traditionally are furniture and other items that would be treasured for generations. From children's wooden toys, a bicycle made of wood for riding enthusiasts; to a whole bedroom suit and grandfather clocks the display had something for everyone.



The WoodMobile is equipped with many hands-on displays that captured the attention of those who visited. Some of the attractions include a showcase of products that we use everyday that have wood or wood product in them, a section devoted to Forestry in PA, and an interactive video on invasive species.

The WoodMobile and the Wood displays was featured on the Pa Cable Network (PCN) several times during the week. HDC has received great reviews to the broadcast. Both Governor Tom Corbett and Governor-Elect Tom Wolf visited the display during the week. Governor Corbett commended HDC on their efforts in putting the WoodMobile together. Governor -Elect Wolf expressed a strong interest in the message of the WoodMobile, and wished the Council great success.
